

## Lee Sprague to Highlight CACC's 2010 General Membership Meeting

Lee Sprague, Tribal Council Member, and former Ogema or Chief, of the Little River Band of Ottawa Indians and former Clean Energy Campaign Manager for Michigan Chapter of Sierra Club will address CACC's 2010 General Membership Meeting. The meeting will be held Sunday, June 13<sup>th</sup>, 2010 from 1 - 5 PM at the Fireplace Room of the Unitarian Universalist Church of Greater Lansing, 855 Grove Street, East Lansing, Michigan. Mr. Sprague will speak on: "Environmental Justice - and Building Coalitions to Protect the Great Lakes." Mr. Sprague has a degree in International Indigenous Law from San Francisco State University and has a wealth of experience in grassroots organizing on environmental justice and energy issues.

### Listen to the Youth - They Are Our Future!

CACC is growing! A Youth Group has formed from the young people who worked last summer at the CACC Snack Bar at the Wheatland Music Festival. These young people, nurtured by the fine arts and music, aware of the great beauty of their Great Lakes home and the impact of our human footprint, have enthusiasm, good ideas and want to put those ideas into action. Gretchen Michaels, CACC Director, is facilitator of the Youth Group.

The CACC Kitchen at the Wheatland Music Festival in September in Remus, Michigan is CACC's biggest fundraiser. We bring healthy, hearty food to thousands of hungry Festival-Goers. It also is an opportunity to educate about local food and other issues generic to our watershed. In a momentous victory, the Huron Environmental Activist League (H.E.A.L.), CACC's chapter in Alpena, working with Earth Justice and other groups nationwide, spurred EPA - for the first time ever - to regulate emission levels of mercury and other toxins from cement kilns. H.E.A.L. and CACC joined with many other Michigan groups advocating for clean energy alternatives, and took part in educational efforts which helped stop construction of two coal plants, that would have added to pollution in Michigan, in the location the mining occurs and where the wastes are stockpiled.

CACC's involvement with the Great Lakes Health Banner, begun in Michigan over a decade ago by Mary Ann Stroup and Families for Environmental Awareness, continues to grow! CACC member Toby Benetti, a Lansing area resident, now houses the Banner, with panels representing over 80 Great Lakes organizations. The Banner is a visible call to action for our communities to eliminate environmental toxins that harm the health of our children and the Great Lakes watershed.

The CACC board is proceeding with preparatory work to turn CACC's office in Lake Station into an energy-efficient building that we can use for future workshops and educational events. The office is a deeply appreciated gift from a local donor.

CACC participates in the Michigan Network for Children's Environmental Health, and recently endorsed the Diesel Clean-Up Campaign. CACC is a member of the Michigan Environmental Council and Earth Share of Michigan and participates in Great Lakes United's Green Energy/Nuclear Free Task Force. CACC is one of several intervening groups and individuals working for clean energy in Michigan, who are opposing a proposed nuclear reactor in Monroe - a threat to the health of our watershed.
